### **Enagic Indonesia.PT In House Payment Agreement**

The commission will be separately paid out when the Applicant pay for the deposit. Sponsor agrees that the 2<sup>nd</sup> commission to be withheld by Enagic. The withheld amount is non-refundable, and may only be paid out upon full settlement by the Applicant. Upon approval of the application for the repayment plan, Enagic will debit the amount from Applicant’s saving account for 10 or 20 consecutive months. For any declined (for any reason) payments on the due date (20<sup>th</sup>), a IDR 70.000 late fee will be charged to Applicant’s saving account the following Business day. In the event of payment default by the Applicant under this Agreement, Enagic shall be entitled to demand that the Applicant voluntarily surrenders the Leveluk machine to Enagic and we reserve the right to report lawyer for further action.
